RELEASE AND WAIVER OF LIABILITY:

IN CONSIDERATION of being permitted to participate in any way in Everglades Bicycle Club sponsored Bicycling Activities ("Activity"), I, for myself, my personal representatives, assigns, heirs, next of kin and any others who may claim on my behalf:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of the Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of bicycling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: (a) THE ACTIVITY INVOLVES RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inaction, the actions or inactions of others participating in the Activity, the conditions in which the Activity takes place, or the NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.

3. I HEREBY RELEASE The Everglades Bicycle Club, board members, officers and agents, volunteers and members, any sponsors, advertisers, and owners and lessors of any premises on which an Activity takes place (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELLEASEES OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS. I hereby discharge all RELEASEES from any such claims or causes of action, agree not to sue any of them for any of such claims or causes of action, and agree to indemnify them and hold them harmless from any violation of this Release and Waiver of Liability.

4. If the CLUB serves alcoholic beverages at or in connection with an event, the above paragraphs 1, 2, and 3 apply in full to any claim in any way connected with the service of such beverages. I ACKNOWLEDGE THAT IF ALCOHOLIC BEVERAGES ARE SERVED, IT IS MY OBLIGATION NOT TO DRINK SO AS TO ENDANGER MYSELF AND OTHERS.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
