### Dr. Deirdre Marshall



Dr. Deirdre Marshall is a Plastic and Reconstructive surgeon who has been in practice in Miami, Florida for twenty-seven years. Dr. Marshall was born and raised in West Virginia, the daughter of two physician parents. Her parents were both immigrants from Belfast, Northern Ireland. Her parents came to America to teach at the Mayo Clinic in Rochester, Minnesota. Her parents were later recruited as founding faculty members of West Virginia University Medical School. Dr. Marshall decided at the age of nine to become a physician, following in the footsteps of her parents. Her undergraduate studies were carried out at Yale University. There she received a B.A. with honors in French Literature and studied extensively in France. She thereafter attended medical school at Stanford University, in Stanford, California. Dr. Marshall completed an integrated residency training program in general surgery and plastic surgery at Stanford University. She completed her fellowship training in hand surgery, microsurgery, and cosmetic surgery. During her training, and in her plastic surgery practice Dr. Marshall participated in many charitable plastic surgery missions in countries such as Viet Nam, Peru, Brazil, Mexico, Malaysia, Honduras and Ecuador.

Dr. Marshall has practiced a wide range of plastic surgery, including pediatric plastic surgery, cleft lip and palate repair, microsurgery, cancer-related plastic surgery focusing on breast reconstruction, and cosmetic surgery. She has received numerous awards and recognitions in her field. Dr. Marshall is a Plastic Surgery board examiner, and she most recently served as the president of the Miami Society of Plastic Surgeons (MSPS). Dr. Marshall is proud to have been the first female elected officer and president of the MSPS. Dr. Marshall has written numerous publications in her specialty and has presented many educational plastic surgery talks and courses. She has been involved with community organizations and breast cancer support groups such as the annual Day of Caring for breast cancer survivors and their families.

Dr. Marshall upholds a philosophy of hard work, caring, compassion, and physical and spiritual fitness. She has been involved in athletic endeavors since her youth. She competed in varsity swimming, diving, field hockey, track & field, cross country, and downhill skiing.
